Resource Centre solution in the offing to ease virtual information access, enhance corporate history archival

The Resource Centre is developing an online portal to help in access of both manual and digital-based information and provides a repository for ORPP classified materials. The portal already basic set up is available on the Local Area Network (LAN) for internal use and is now awaiting necessary internal publics input and approvals.

It contains two main categorisation- general bibliographies of the centre's collection and part of ORPP's institutional repository. In each of the categories, there are various modules for search, users' registration, access control levels, statistics and feedback avenues from the users. The system seeks to enhance efficiency and convenience in access and retrieval of available information, including any manual or digital subscriptions

The Resource Centre in-charge, Beatrice Amollo, on the 19th January, 2022 run some departments/units that comprised Finance, Planning, Corporate Communication and ICT through the operations of system. In the formulation of the space, she noted that security, necessary work flows and necessary backups are factored in line with system development tenets. "This milestone we are about to attain is important even as I call on staff to make use of the Resource and benefit from what is already a considerable physical and multi-media materials", noted the Librarian.

"It is important to have a session for us to go through the initial phase and provide input before the system is presented for necessary approvals and to the rest of staff before roll-out", noted Joseph Kanja, head of Planning department. His counterpart Abdirahman Hussein appreciating the effort noting that the portal is a step to the direction of actualising Office strive of establishing the Resource Centre. "As we move on and even create public access links as guided, let us incorporate input of the deliberations and continually collaborate with ICT for the necessary technical advice to better such an important system", noted Yatich Kevin of Finance department. It was also observed the need to finalise the draft

The Office mooted the process of establishing a Resource Centre in 2019 to act as information hub on matters related to mandate of the Office. So far, milestones such as allocation of space, recruitment of substantive Librarian and acquisition of some resources have been made. Collaboration with the Kenya Library and Information Services Consortium (KLISC) is being explored to broaden the information resources for the Centre.

ORPP part in forum forming Women Coordinating Committee on elections

The Office of the Registrar of Political Parties (ORPP) was among the lead institutions that witnessed establishment of a Women Coordinating Committee on Elections (WCC) in a forum held on 14th January, 2022 at the Crowne Plaza, Nairobi.

The 7-member team has its membership drawn from representation of various public and non-state organizations led by the Independent Electoral and Boundaries Commission (IEBC). Some of its tasks deliberated and agreed during the meeting inter alia are the following:

- a) To collaborate with IEBC to formulate appropriate strategies and targeted programmes to enhance monitoring and evaluation of participation of women throughout the electoral cycle while pooling resources;
- b) To support in development and distribution of women targeted voter information and communication materials;
- To collaborate with IEBC in conducting voter education for members of their representative groups;
 Encourage member organizations to apply for accreditation as election observers and voter education provider for all activities across the electoral cycle.

Registrar of Political Parties, Ann Nderitu in her remarks made by the Senior Administrator, Jane Njeri who represented her in the forum, pointed out the disproportionate participation of women in politics over the world visa-vis the world's women population. "A global study that was carried out in 2019 indicated participation of women in national level Parliaments was only 24% which accounted for 8% of national leaders", cited a recent report. Such she noted, only arguments the fact that there are unique challenges that women grapple with in their effort to participate especially in politics.

She noted of the deliberate efforts ORPP had put in place in creating positive and safe space for women to participate in politics. For instance, in order for a political party to be registered, it must meet the conditions spelt out in section 7 of the Political Parties Act, 2011 which among others, requires that Special Interest Groups are incorporated in their respective governing organs and membership register, failure to which there are sanctions including a provisionally registered party not to attain full registration".

The Registrar emphasized continual inspections that Office undertakes to ensure that political parties' have structures to enable women actively engage in the internal affairs of political parties including in governing organs. In addition, she informed of ORPP's robust capacity building forums run for women aspirants. "These fora aim at sensitizing the women about the constitution and other electoral laws in order to enhance their readiness to participate in politics and also scale up their personal development and leadership skills so that they can successfully engage in the political arena and actualize their political ambitions", the Registrar noted. Adding that women should hold one another hands to benefit in efforts of various players like on the Coordination Committee that will bolster women potential and capabilities to not only vie successfully for political positions but also influence the formulation of policies that will positively impact the lives of Kenyans.

Notable speakers who also spoke on varied facets on the subject of the forum's deliberations were among others: IEBC's Vice Chairperson Juliana Cherera, Commissioner Francis Wanderi and Joyce Ekuam Director, Voter Education, Partnerships and Communication. Some of the institutions present and whose representatives will sit in the WCC are; Women Empowerment, Badili Kenya, Mzalendo Trust, Legal Sisters, The University of Nairobi and Humming Bird Initiative with IEBC as ex- officio.

She was buried at Muthengera sub-.location, Igua Miti Ward in Laikipia West subcounty on 7th January, 2022, a day preceded by a requiem mass at her worship church at Buruburu Phase 1, Presbyterian Church of East Africa

External stakeholders and staff alike still recount the work and welfare-oriented interactions they had with the late colleague with most still finding it difficult to bear "I still remember her vividly especially as I serve at the Registrar's office", Josephine Wanjiru, an Office Administrator recollected in conversation with this *Bulletin* desk. "It is quite shocking but we should try to come to terms with the turn of event and as a tradition of this Office, offer her a befitting send-off", noted John Macharia, the Chairperson of the burial preparatory committee during one of the burial preparatory meetings.

Moving tributes were put forth by family, neighbours, colleagues and friends, painting a picture of a well-deserved person who lived and served in diversity of social and work portfolios with ultimate commitment. "Sadly we lost a dutiful, foresight and forthright colleague. Alice remains in the roll of critical personnel that contributed to the process making the ORPP, an independent Office we are today. She was a professional figure whose ability to manage disparate internal and external stakeholders' demands and orientations stood out", noted Registrar of Political Parties, Ann Nderitu in her tribute during the burial. The Registrar further thanked staff for support to the late. "I express sincere gratitude to your voluntary individual support to the departed colleague... The support for one another is encouraged not only in trying times but in good times", said the Registrar in
