Pomp and colour at ORPP Post Poll report launch, stakeholders call for Office strengthening

 ${f T}$ he Office of the Registrar of Political Parties (ORPP) unveiled its 2022 Post Election Evaluation Report on 2nd August 2022. The report is a culmination of a journey towards the development of the report that commenced with internal drafting shortly after the 2022 general election. It was further subjected to a series of ORPP internal reviews, repackheld in June, 2023.

Speaking in the well-attended spectacle event at Safari Park Hotel, Nairobi that included representatives of; political parties', state agencies, donor partners, civil and religious outfits amongst, lauded the ORPP's raft of initiatives in the run up, during and after the election stipulated in the report.

Chief Guest Hon B.N. Muturi, the Attorney General called for the need to strengthening the Office of the Registrar of Political Parties, anchoring its establishment in the Constitution. He further called for timely enactment of any review of the law to avoid experiences of rush of amendments witnessed in the last election. "I call on relevant state arms to

enhance capacity of the ORPP including its establishment in law and spread across the country", Muturi noted. The AG further called on respect for political parties and their organs. He noted, "We must treat political parties to better 'hygiene' they deserve. It is the right time for political parties to harness the moment and be counted in the progressive agenda and put forth legal reform proposals' also as well aging, stakeholder assessment and its eventual validation as be actively involved in current national political discourse"

The Registrar Ann Nderitu while giving an overview of the report called on stakeholders to raise their responsiveness on their citizen engagement initiatives. Some of the key milestones were; legal reforms, Political Parties (membership) Regulations; ICT re- engineering; countrywide sensitization; clearance of independent candidates, partnership with Political Parties Liaison Committee (PPLC) in staging peace caravans; registration of parties; confirmation of coalitions/coalition political parties; training of party agents among others.

Assistant Registrar of Political Parties, Ali A. Surraw formulated the report as an important discourse for everyone including the stakeholders. "It is part of a continuous learning as we look at the review of our programs for better service delivery. We will have an open session and invite feedback to improve our next course of action in the next electioneering cycle," said Ali A. Surraw.

"We commit to working collaboratively in developing Regulations for coalitions/coalition, timely electoral reform, better involvement of Special Interest Groups. All stakeholders need to raise the bar engaging the citizens through respective areas of operations", Nderitu said.

Other speakers appreciated continued partnership with ORPP. "We salute ORPP in developing publications and reports that have improved election administration and management", Joshua Changwony, Uchaguzi Platform convener. "The Steering Committee of PPLC will continue to partner with ORPP to foster amicable political dialogue. However, there is need to continue to enhance financial capacity including the Political Parties Fund", Christopher Kilonzo, Vice-Chair Steering Committee. The young deserve political stability. In parties, it is imperative to promote greater representation and involvement of youth and women. Some of the benefits of incorporating diversity and inclusion within political parties include the following.

> 1. Enhanced Representation: Youth and women make up a significant portion of the Kenyan population thereby their inclusion in political parties will ensure that their concerns, interests, and aspirations are adequately represented in the decision-making process.

This can lead to policies and initiatives that address the unique challenges faced by these demographics for a more inclusive and equitable society.

- 2. Fostering Innovation and Progress: Diverse political parties bring together individuals from various backgrounds. experiences, and perspectives. This diversity of thought leads to innovative solutions to societal issues and fosters progress in governance.
- 3. Strengthening Democracy: Inclusive political parties are essential for building a strong democratic foundation. When all citizens are represented and valued, they are more likely to engage in the democratic process, leading to increased voter turnout and political participation. This, in turn, strengthens the legitimacy and credibility of democratic institutions.
- 4. Improved Public Perception: Political parties that actively promote diversity and inclusion are viewed more favourably by the public. Such parties demonstrate a commitment to equal representation and are perceived as more responsive to the needs of the people they serve. This can result in increased trust and support from the electorate.
- **5. Increased Voter Turnout:** By empowering youth and attract a broader voter base. This, in turn, can lead to indemocratic process.
- 6. Fostering Long-term Party Loyalty: Engaging youth in political parties early on cultivates a sense of loyalty and commitment that can endure for years. Such continuity strengthens party structures and increases its long-term via-

To promote inclusion for Youth and Women Involvement some of the following:

1. Capacity Building Programs: The Registrar collaborates with partners and other stakeholders in implementing capacity building programs for political parties. These programs focuses on leadership development, political training, and advocacy skills specifically tailored for youth and women. Building their capacity empowers them to become effective leaders and advocates within their parties and the political arena.

Affirmative Action: Implementing affirmative action

measures accelerates the inclusion of youth and women within political parties. The Political Parties Act 2011 has put in place measures to ensure representation in party governing bodies and party membership by requiring them to reflect gender balance and inclusion of special interest groups. Further under funds distribution, there's a fifteen percent of fund which is divided proportionately to political parties based on number of candidates from special interest groups elected in the preceding general election.

Expanding the outreach through;

1. Educational Campaigns: The Registrar of Political Parties is keen on expanding the outreach through educational campaigns aimed at raising awareness about the importance of diversity and inclusion within political parties. These campaigns is targeting both party members and the general public, emphasizing the benefits of youth and women participation and dispelling any misconceptions or biases.

Networking and Mentorship: Facilitating networking opportunities and mentorship programs for young and aspiring political leaders is another strategy which will enable women and youth to connect with experienced politicians and gain valuable insights. Mentorship will provide guidance and support, helping youth and women overcome barriers and succeed in the political sphere.

The Office of the Registrar of Political Parties' leads Kenwomen to actively participate in politics, political parties can ya's efforts towards ensuring not only compliance with the law but also taken deliberate efforts in supporting political creased voter turnout during elections, strengthening the parties and targeted special interest groups to active participation. These efforts result to these groups become more engaged, the overall political environment will become more inclusive, responsive, and effective in addressing the needs of all Kenyan citizens. Ultimately, diversity and inclusion, particularly through greater involvement of youth and women, in a collaborative approach will buttress democratic thrift in Kenya.

ORPP supports Mathare-based community peace dialogue

The ORPP has called for peaceful co-existence of Mathare, Huruma area residents and all communities in a forum held on 30th July 2023. Participants were sensitized on causes of conflict, conflict prevention, and conflict resolution mechanisms.

The training objective was to engage the community-based leaders on ways of maintaining peace, security, and build-

ing cohesion. ORPP outlined measures taken to enhance peace which were holding dialogue grassroots forums, holding peaceful caravans in hotspot areas capacity building of political party officials among others. "The ORPP has made every effort to ensure there is a peaceful political en-

vironment including being a member of the Uwiano Platform for Peace and also regulating political parties involved in violence incitement in accordance with the law" added ORPP representative Beatrice Nderi.

Caleb Ouma who is a drug reformist stated the various reasons which contribute to violence in society among them joblessness among the youth, tribalism, illiteracy, and political incitement among others. 'Many youths have been the victims of political violence and are abandoned thereafter, it is high time we educate them on the importance of peace and cohesion." added Caleb.

Other facilitators called on the organizers to conduct more community dialogue forums in order to enhance civic education on the importance of peace and conflict management. The participants appreciated ORPP's fi-

nancial support of the program and promised to enhance collaboration on upcoming future programs.
