The Cabinet Secretary Hon. Aisha Jumwa, Ministry of Public Service, Youth and Gender Affairs officiated the forum with stakeholders drawn from civil society actors, policymakers, development partners, and women's rights organizations among others.

## Political Parties officials undergo training on the Political Parties Fund

The ORPP held a sensitization meeting with 48 Political Parties that currently qualifying for the Political Parties Fund (PPF) on the commencement of the Financial Year 2023/2024. The engagement revolved around the process and distribution of allocation of Political Parties Funds to qualified Political Parties as per the conformity of the Law.

"We are happy to report that all the 48 political parties have received the funds for the last financial year. Unfortunately, some have not been able to utilize the funds due to compliance issues which raises concerns to our Office with the Auditors through financial statements. As officials of political parties we do request that you prepare accurate Financial Statements and acknowledge receipt because they form the basis of the audits" said Registrar of Political Parties.

Office had requested for more allocation of the fund from the current percentage from the National government so that Parties would run appropriate activities more effectively and urged them to lobby for the push since they are the lawmakers and are the advantage point of making such requests.

The Senior Chief Finance Officer, Joshua Kimulu presented the analysis on the distribution processes and disbursement. He urged the officials to make fresh applications using fully filled prescribed forms PP1 and PP2 as well as present a contained work plan to the office as required by the law.

Distribution of Funds are according to Section 25 of the PPA which outlines; 70% of the Fund reference to the total number of votes secured in the preceding election; 15% proportionately on the number of elected Special Interest Groups (SIGs); 10% based on the total number of representatives elected and 5% for Administrative duties of ORPP.

### Thousands express interest to serve at ORPP, as the recruitment progresses

Close to over 8,000 persons expressed interest to work with ORPP according to the analysis of the number of job applications received for the 26 positions declared in varied cadres. The jobs were advertised vide *My Gov* Newspaper publication on 7<sup>th</sup> February, 2023 and further published on Office website and social media platforms. In the period, the job advert social media platforms and numerous digital avenues were awash of the ORPP vacancies. This was posted on 28<sup>th</sup> February, 2023.

Further, a shortlisting exercise was undertaken on 8th to 13th May, 2023 and interviews conducted between 7th to 14th August, 2023. The process is at the tail end is being headed by Human Resources Management Department. In the course of the process, identified staff in different departments demonstrated team spirit supporting different aspects receiving, sorting and recording of applications; data entry, shortlisting and interviews as well as varied reports required for each stage.
