# ORPP leadership appears separately before National Assembly and Senate's Justice and Legal Affairs Committees

July, 2024 Edition

The ORPP apex leadership; Registrar and Assistant Registrars appeared before the National Assembly's Justice and Legal Affairs Committee (JLAC) to present on Supplementary estimates No. 1, FY 2024/2025 on 17<sup>th</sup> July 2024 at Parliament Buildings.

The Registrar of Political Parties, Ann Nderitu CBS, leading the team, requested for the reinstatement of the budget which had been significantly reduced, noting that adequate budget allocation is critical for the Office fulfilling its mandate.

On a related matter, on 22<sup>nd</sup> July, 2024 the Office appeared before the Senate Justice, Legal Affairs and Human Rights Committee (JLAHRC) to table its views and position on four (4) Senate Bills under discussions at Senate Chambers, Parliament Buildings. The Bills the Office presented on together with over 10 other stakeholder public and private entities with a focus on The Political Parties (Amendment) Bill, 2024, which were under public participation. Other Bills under the consideration were; The Election offences (Amendment) (No.2) Bill 2024), The County Governments Election Laws (Amendment) Bill, 2024 and The Elections (Amendment) (No.2) Bill, 2024.

In reference to Bi-partisan process as outlined in the NADCO report, The Political Parties (Amendment) Bill falls foul of fundamental issues that the Office presented during Bi-partisan sittings that intended to enhance party discipline, fidelity to parties and better governance", submitted the Registrar Ann Nderitu, CBS as part of comprehensive memoranda on the Bills under discussion.

The Registrar reiterated and urged the Committee of the need to strengthen the ORPP, while anchoring it in the Constitution as one of the ways of preserving the gains the Office and political parties had made in promoting governance and enhance democratic ideals.

Bomet County Senator, Hillary K. Sigei, who chairs the Committee assured that it will consider the Office submissions for better representation and inclusion in political parties registration and regulation.

Stakeholder present that included Independent Electoral and Boundaries Commission(IEBC), Attorney General, Political Parties Liaison Committee, National Gender and Equality Commission, NCPD, ELGIA, FIDA were in support of strengthening of ORPP. They acknowledged the ORPP's progress under legal instruments them noting, the milestones under the Registrar's and Assistant Registrars' leadership.

### ORPP's hold talks with USAID

The Registrar of Political Parties and officials of US Agency for International Development (USAID)held a consultative session, on 3<sup>rd</sup> July 2024 at Registrar's office as part of ORPP's continued partnership USAID. The deliberations sought to lay strategies to enhance citizens' information sharing with a focus on political education.

Registrar, Ann Nderitu, CBS, during the session expressed gratitude for USAID's continued support including development of training manuals and Office sensitization of Special Interest Groups' grassroots and a host of

stakeholder engagement forums, some spearheaded by ORPP's regional offices.

"We look forward to further grassroots engagements and capacity building of political parties to improve governance, transparency, and accountability", assured Assistant Registrar, Ali Abdullahi. Assistant Registrar, CPA Florence Birya noting the Office's commitment in enhancing inclusion on all its processes and programmes as required in pursuit of its mandate.

The USAID representatives commended ORPP's initiatives and reaffirmed their commitment to supporting upcoming programmes in line with Office strategic focus.

#### PRFD, the 5<sup>th</sup> in provisionally registered parties list

The People's Forum for Rebuilding Democracy (PFRD) was handed in its certificate of provisional registration by the Registrar on 4th July, 2024 after fulfilling the requirements for the 1st stage of registration. The party is among the currently six provisionally registered. The others parties in the category are Chama Changamko Kenya (CCK), The We Alliance Party (TWAP), National Economic Development Party (NEDP) and latest registered being Imarisha Uchumi Party (IUP). The Registrar of Political Parties, Ann Nderitu. CBS while applauding its founding members. urged them to steer the party programmes to advocate for change and transformation. She further called for adherence to their party's constitution and Political Parties Code of Conduct.

Assistant Registrar, Registration and Field Services, CPA Florence Birya encouraged the founders to enhance democratic practices through rolling out inclusion programmes as outlined in various party documents.

The ORPP team briefed the party officials on the next stage of registration. The requirements include recruitment of required members, with representation of Special Interest Groups. financial accountability, establishment of county offices, constituting the governing bodies, record management in adherence with data protection among others conditions for full registration under section 7 of The Political Parties Act. 2011.

The founders appreciated the guidance received through the registration process right from reservation of party particulars. They committed to pursue the next phase to full registration as soon as possible.

The thematic focus of Registrar's address was on Kenya's Political System and History with a reflection on traditional & colonial governance and turns and gains of political parties establishment over the Kenya's independence.

## Imarisha Uchumi party, latest provisionally registered

Imarisha Uchumi Party (IUP) is the latest provisionally registered party after Registrar issued a certificate of provisional registration to a section party officials and members, on 12<sup>th</sup> July 2024 at ORPP headquarters.

"Work through the process of full registration within set timelines and conditions with integrity. This should include obtaining members consent on recruitment as well as upholding cordial relations of incoming officials with founding members", Registrar, Ann Nderitu, CBS guided".

"You must constitute governing body and other organs of the party that have interest of party and members. This will help attain party ideals and constitution including persuading them based on your ideology "Assistant Registrar, CPA Florence Birya, Registrar and Field Services Coordination guided.

Assistant Registrar, Ali Abdullahi as he wished well the party bearing in mind a host of compliance requirements.

A section of staff present led by Direction Compliance, Daniel Kinuthia and Head of Registration Department Locha Erukudi briefed of the party requirements for full registration. These included rights and privileges party at the initial stage, conditions for full registration, ICT obligations, management of records, financial accountability as stipulated in varied provision of the Political Parties Act. 2011.

Over 500 PWDs projected for training ahead of 2027 elections; Registrar projects in a roundtable inclusion discussions

The ORPP was central in facilitating a round-table discussion forum held on12th July 2024 in Nairobi to discuss inclusive initiatives for People with Disabilities. The forum was organized by United Disabled Persons of Kenya (UDPK) and the Commonwealth Disabled People's Forum (CDPF). Key focus of the session was to evaluate the progress and challenges made in implementation of the United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) in Kenya the different players.

Speaking as a lead panelist, the Registrar of Political Parties, Ann Nderitu CBS, emphasized the need for a comprehensive review of the legal framework to ensure greater inclusion of People Living with Disabilities (PWDs) in governing bodies, and operations of political parties.

"We must continuously provide capacity-building initiatives for party officials to advocate for the formation of PWDs caucuses, mobilize them to participate in electoral activities, and promote synergy among stakeholder bodies to realize their political rights," said the Registrar, outlining ORPP's initiatives to enhance the inclusion of PWDs.

The Registrar while speaking on gaps in enhancing the representation of persons with disabilities in political processes outlined the ORPP's dedication to advocating for the rights of marginalized groups, including persons with disabilities. She highlighted the Constitutional provisions that promotes inclusion of PWDs. She however, decried the existential legal and under representation that continue to fall short of the threshold of the Constitution. She pointed out key proposals to mitigate such shortfalls as contained in ORPP's 2022 Post-Election Evaluation Report and other taskforces. Some of them being legal reform and enhancing affirmative action interventions. Building on marginal gains (increase of number of candidates with disabilities from 60 in 2017 to 127 in the 2022 election was seen necessary).

Stakeholders present also discussed additional measures such as social protection, skills provision, adequate funding, creating PWD-friendly environments and supporting civic education programs to uphold the rights of PWDs in Kenya as per the convention.

The meeting organizers called for government's support in preparation for adoption of a Disability Inclusion Strategy scheduled for discussions during a Commonwealth Heads of Government Meeting (CHOGM), scheduled for October this year. The forum made crucial steps towards a more inclusive political landscape in Kenya, aligning with the global commitments of the UNCRPD. The ORPP's participation was coordinated by the Resource Center which has also been designated as a disability desk at ORPP.

# Parties forge PPLC's nominee election modalities and elect representatives to the IEBC select panel

The ORPP convened a National Steering Committee Plenary meeting of the Political Parties Liaison Committee (PPLC) on 22<sup>nd</sup> July 2024 to discuss nomination process of its three-slot nominees to the Independent Electoral and Boundaries Commission(IEBC) Commissioners selection panel. The meeting was supported by Netherlands Democratic Institute (NDI).

The meeting generated heated debate, with political parties representatives having contrasting views on mechanisms of the election.

The ORPP and Independent Electoral and Boundaries Commission(IEBC) offered necessary guidance for an accountable and transparent nomination process while emphasis the need best suited representative to the panel.

In the meeting, the parties endorsed their Steering Committee's Secretary, Taabu O. W. Daniels, the only candidate applied for the position. He was declared the bearer to the Secretary's Office.

## Trio to carry the PPLC flag to IEBC select team

Three elected representatives of the National Political Parties Liaison Committee (PPLC) were elected and declared on 26th July, 2024 in a cluster-based voting to sit as representatives of the Independent Electoral and Boundaries Commission (IEBC) Commissioners. The three for three clusters of non-parliamentary, minority and majority elected in a closely contested feat were; James Evans Misati (Non-Parliamentary cluster), Muli Augustus Kyalo (Minority) and Bore Nicodemus Kipchirchir (Majority). The outcome of the election was declared by Machakos County Elections Manager Nelly llongo leading her IEBC officials to conduct the exercise.

Other candidates in the race were Gor Lilian Anyango, Kathuri Amos Mugambi (Non-parliamentary cluster); Grignon Koki Muli (Minority cluster) and Wachira Benedict Wandeto (Majority cluster).

The party representatives were lauded for peaceful and transparent elections.

The National Democracy Institute supported the event. The parties were grouped in clusters based on current constituent parties in each. These are Kenya Kwanza Alliance (18 parties), Azimio la Umoja One Kenya Coalition Party (23) and Non-parliamentary parties (49 parties). A total of 8 candidates vied for the slots with 3 representing non-parliamentary cluster, 2 minority cluster and 2 majority cluster.

"It is my appeal to the declared representatives to put forth the interests of parties while

considering the views of party representatives as they sit in the select panel", urged the Registrar Ann Nderitu, CBS.
