ORPP unveils Political Parties Fin.Manual, engages Parties on audit

September/October, 2024 Edition

The ORPP on 13th September, 2024, at Safari Park Hotel launched the Political Parties Finance, Accounts & Procurement Policy and Procurement Manual. The manual is a crucial tool to guide political parties undertake the finance and procurement processes in conformance with finance and procurements and expected standards.

Stakeholders present hailed the ORPP for developing such the comprehensive manual, noting terming it useful and key reference material not just to the parties but also their entities.

The occasion was presided over by the Auditor General, FCPA Nancy Gathungu and hosted by the Registrar. Participants were drawn from public entities such as National Treasury, Public Sector Accounting Standard Board (PSASB), IEBC, political parties and a host of other non-state actors and partners.

The Registrar of Political Parties, Ann Nderitu, CBS called for optimal use of the manual and assured ORPP will in collaboration with the Auditor General and other partners roll out a series of sensitization to political parties for proper and better use of the Manual.

She thanked the HSF, staff and other entities that supported the rigorous development, series of reviews and eventual publication of the Manual.

The Registrar underscored the need for proper use of funds including the Political Parties Fund

For parties' enhancing of representation in Parliament, shape opinion and policy, undertake election related activities among others.

"The shall support political parties teaming up with the good efforts of ORPP as part of its mandate of ensuring effectiveness of internal controls ,risks and utilization of public expenses to be in line for the intended purposes", said the Chief Guest, FCPA Nancy Gathungu.

She called on Political Parties to have formal and informal norms to be adhered to including financial and procurement processes. "The simplified Manual will be a critical aid in attaining credibility and legitimacy and streamline governance and management of party processes", the chief guest said.

ORPP unveils first of its kind PWDs Political Education Manual

The ORPP, at KICC Nairobi on 8th October, 2024 unveilled yet again in the month- the Political Education Training Manual for Persons with Disabilities (PWDs).

A pioneer initiative aimed at empowering individuals with disabilities to actively engage take up leadership responsibilities including in political parties and elective positions. The Manual is designed to provide PWDs with the knowledge and skills necessary for meaningful participation in the political landscape.

Registrar of Political Parties Ann Nderitu expressed gratitude to the guests and stakeholders who contributed to the Manual, terming it essential in strengthening disability inclusion in electoral and political processes.

She emphasized that PWDs inclusion and participation is Constitutionally protected so as their voices are represented in policymaking and decision-making. The Registar further called for a re-evaluation of the legal framework to address gaps and enahnce equitable inclusion of PWDs in political processes including better ways in their nominations.

The chief Gguest, Sen. Hon (Dr.) Isaac Mwaura, appreciated the ORPP effort in developing the Manual noting is an authorative reference material for PWDs capacity building and engagements ot just for political parties but a cross section of stakeholders. In his key note address, punctuated by his life story and testimony as a PWD, he highlighted the significance of the Manual as a collective commitment to ensuring that the voices and concerns of PWDs are heard within the political space. He stressed the importance of inclusion in shaping policies and decisions that reflect the needs of all citizens, including those with disabilities.

Assistant Registrar Mr. Ali Surraw described the launch as a moment of reflection and renewed commitment to inclusivity, celebrating the milestones achieved by the ORPP in promoting disability inclusion.

Assistant Director of Capacity Building, Ms. Anastacia Kaberere, provided a brief overview of the Manual, explaining that it is a comprehensive guide designed to equip PWDs in Kenya with the knowledge and skills required to navigate the political system stemming from the ealier ORPP developed Political Education Source Book. The Manual covers various aspects of political processes and offers practical tools to help individuals engage effectively including campaign stragies, resource mobilisation, strategic communication and personal branding of persons interest in political leadership.

The launch of the Manual is one of the ORPP's significant step toward creating a more inclusive and participatory society, a demonstration of its commitment to promoting meaningful involvement of all Special Interest Groups (SIGs) including the marginalised and ethnic minorities.

The launch set off a series of capacity building initiatives aimed at senstizing target SIGs on practical ways of implemeting the Manual within political parties and in their individual endeavours to participate in elective and political parties leadership.

Accounts section spearheads preparation of last year's financial statements

The Accounts section has spearheaded and submitted the ORPP Financial statements, FY 2023/24 to relevant authorities with set timelines of 30th September. This was after the statements

preparation in a various of sittings by a section of staff and series of reviews by the Management and Audit Committee prior to finalisation. The preparation was in line standards of financial reporting on Cash Basis of Accounting Method under the International Public Sector Accounting Standards (IPSAS).

In a session to review the statements held from 2nd to 7th September,2024, a section of staff involved comprehensively reviewed the Office financial statements the Office operates. They are for the Recurrent, Political Parties Fund and the Staff Mortgage and Car Loan Scheme.

"This session is an opportunity to assess the Office's financial health, underlining that all departments are responsible for the Office's financial management. The preparation of the report should adhere to financial reporting standards as stipulated in relevant laws & regulations and Strategic Plan," said Assistant Registrar, Ali Abdullahi. He urged the team to observe the accuracy and integrity of financial data and reporting requirements and timelines. He also noted the Office's approach to such team assignments geared towards enhancing collaboration and teamwork. The Assistant Registrar urged the team while preparing the financial reports and statements to embrace forward planning and reflect on successes and areas of improvement.

He appreciated the team's dedication and commitment in the assignment that has resulted to the Office's recognition and receipt of various awards in the previous reporting periods.

Audit Committee quality-assures ORPP's financial statements

The Audit Committee conducted a thorough review of ORPP financial statements from September 15th to 20th, 2024. The review was besides the legal requirement, an attestation of ORPP's commitment to ensuring transparency and accountability in its financial affairs.

Assistant Registrar, Ali Abdullahi, emphasized that the review was part of ORPP adherence to the due process in the preparation of financial statements. He reiterated that the ORPP remains dedicated to upholding high standards of financial management.

Assistant Registrar, CPA Florence Birya expressed appreciation for the valuable insights provided by the Audit Committee, noting that the Committee's contribution ha always aided the maintenance of quality and standards expected of the ORPP's financial reporting.

The Audit Committee Chairperson, Kyalo Mwengi while speaking during the session commended the ORPP for its exceptional performance in financial reporting during previous periods, which reflects its prudent management and strong internal controls. The Chairperson highlighted that these efforts had contributed to the ORPP's stellar reputation in financial accountability including awards in financial reporting.

Head of Accounts, CPA D.W. Osores, pointed out that accounting within the ORPP goes beyond mere figures, as it encompasses efforts in governance, community engagement, staff welfare, and sustainability initiatives. He acknowledged that the ORPP has made significant strides in these areas, contributing to the office's overall impact.

The review session, coordinated by the Accounts and Audit units, covered three key financial statements: Recurrent Expenditure, the

Political Parties Fund, and the Car and Mortgage Fund. Each statement was evaluated for accuracy, internal control effectiveness, and adherence to financial standards. This comprehensive review underscores the ORPP's dedication to financial responsibility and robust governance.

ORPP engages Civil Society groups on amendments to Political Parties Act

The ORPP held a consultative forum with a section of Civil Society Organization Representatives to gather input on the Political Parties Amendment Bill, 2024 on 12th September 2024. The forum, which was part of ORPP's effort to ensure comprehensive stakeholder involvement, aimed to address gaps identified after the 2022 general election and improve the regulation, accountability, and governance of political parties.

Registrar of Political Parties, Ann Nderitu, CBS, highlighted the importance of the amendments, emphasizing that they would help resolve issues that arose during the general 2022 election. She noted that the proposed changes are critical in enhancing the effectiveness of political party operations, ensuring better governance and adherence to regulations.

Assistant Registrar Ali Abdullahi expressed his gratitude to the representatives, recognizing

their crucial role in promoting democracy, fairness, and inclusivity. He noted that their input was vital in shaping a democratic and accountable political system.

Key proposals discussed during the forum included: Party Nominations: Defining Coalition Political Parties, sanctions for breaches of the Political Parties Code of Conduct, qualification criteria for the Political Parties Fund, dispute resolution mechanisms.

This consultative forum, supported by Electoral Law and Governance Institute (ELGIA) sought to incorporate broad spectrum of views before the Bill is further considered by Parliament.

The ORPP has been involving a broad spectrum of stakeholders in the legal reform endeavour to gain deeper breadth and representations.

The forum was part of ORPP effort to incorporate views of broader spectrum of stakeholders prior to the Bills further consideration by Parliament.

The engagement was also an opportunity to connect directly with citizens across the country on ways of promoting transparency and educating the public on their rights and their part

in the actualisation the purposes of political parties in Kenya.

"The alignment of our budget should be within ORPP Strategic Plan and cognizance of economic landscape that require sustainability and creation of positive impact on service delivery," urged Assistant Registrar, Ali Abdullahi emphasized.

The team is undertaking the process in adherence with the prevailing laws and budgeting guidelines. In the session organized by Finance department, the ORPP also undertook assessment of performance through the Programme Performance Review (PPR) for the FY 2021/22 -FY 2023/24 period. The status of implementation of the Strategic Plan 2020-24 was undertaken.

On Thursday, 26th September the Mombasa regional office participated in the Round Table **Engagement of Coast Senate Representatives** and Key Duty Bearers. The meeting was organized by USAID, HURIA and ACT! The theme of the occasion was sustaining civic action for realization of inclusive governance and accountability.

It also discussed on with the participants the challenges faced and how ORPP could collaborate to overcome these long standing difficulties.

The elected representatives present provided a brief on the legislative agenda and policies that they intend to employ to improve inclusion in the upcoming electoral cycle.

The participation was part of ORPP efforts to engage stakeholders at devolved units in a bid to build stakeholder partnerships within the region and beyond.

Minorities and Marginalized Affairs Unit under the Presidency holds discussions with the Registrar.

The ORPP held fruitful partnership discussions on 1st October,2024 at ORPP offices between the Registrar, Ann Nderitu, CBS and the team from Minorities and Marginalized Affairs Unit under the Executive Office of the President while paying a courtesy call to the Registrar.

The discussions took stock of status of affairs of over 79 identified Ethnic Minorities and Marginalized Communities (EMMCs) in 29 counties.

"These discussions are vital in championing against all forms of discrimination and informing legal and policy reforms that address exclusion practices to EMMCs. The ORPP, as an entity promoting good governance, welcomes this partnership. We shall be deliberate in engaging the mapped-out community members through various forums with political parties and other stakeholders. Deliberate efforts to protect and preserve the culture of these groups including language and support their education is not an option for all", noted the Registrar during the discussions while stating the need for an accurate register of the groups.

"There is massive positive impact out of efforts in identifying and having a structured engagement to all the EMCCs who are spread across the country. Having annual Minorities Day every December, developing a national policy, mapping out and supporting their leadership structures are some of the key focus areas of the Unit", observed Hon. Josphat Lowoi Lodeya, the Director of Minority and Marginalized Communities Affairs Unit.

Also present were representatives of the EMMCs including groups Arabs, Shelisheli, Daasanach among others.

"We are encouraged that we have a voice, goodwill and interface through the Minority and Marginalized Affairs Unit and the grassroot leadership for each community we are presently establishing", noted the EMMCs Chairperson Charles Nandain.

The discussions also outlined legal and policy reforms to implement several Constructional provisions on protection of the minorities and marginalized. The groups were called for unity of purpose and structured engagement through

their identified leaders from each community for impactful advocacy on their issues.

Electoral players, ORPP appraise electoral legislation review status

ORPP with a section of stakeholders in electoral reforms held a consultative meeting on 16th to 17th September 2024 to deliberate on a roadmap toward the finalization of electoral reforms.

The Justice and Legal Affairs Committee (JLAC) technical quidance gave on the review/amendments in view of lessons learn in last and ahead of the General Election.

Participants were drawn from among others Civil Society Organizations, Independent Electoral and Boundaries Commission(IEBC), Faith Based Organizations and State Law Office.

During the forum, Assistant Registrar, Ali Abdullahi emphasized the importance of improving democratic systems through the implementation of proposed legal reforms, urging for their timely enactment.

Speakers observed the essential finalization of necessary electoral legislations with reference to processes such as NADCO and other experiences gained in past electoral cycles including timelines.
