Celebrating a Trailblazer : Registrar Ann Nderitu on the verge being electoral Commissioner

The Office of the Registrar of Political Parties (ORPP) joins the electoral and governance stakeholders in celebrating Registrar's, Ann Nderitu, CBS milestone on her appointment as a Commissioner to the Independent Electoral and Boundaries Commission (IEBC).

Ms Nderitu milestone follows a rigorous recruitment process through a selection panel, followed by public interviews, vetting National Assembly's Departmental Committee on Justice and Legal Affairs (JLAC), and subsequent approval by the National Assembly (Plenary). The penultimate step, was her formal appointment by the President through a Special Gazette notice— CXXVII-No. 122 of 10th June, 2025. She is now awaits a legal process of swearing in after a matter in court is determined.

The Registrar, a trailblazer in electoral governance and institutional reform and a multiple awardee, has served the ORPP with distinction, steering the Office through transformative milestones. Her efforts had imprint in strengthening multi-party democracy, deepening institutional accountability, and championing inclusion, particularly for women, youth, and marginalized groups, has earned her national and international recognition.

ORPP convenes PPLC deliberates on legal reform, parties' financial reporting tool

mittee (PPLC) a two-day consultative meeting, 4th to political parties, the Office of the Registrar of Political Parties (ORPP) and the Independent Electoral and Boundaries Commission (IEBC). The tripartite platform served as a crucial space for deliberations on matters integral to democratic governance and electoral integritv.

Deliberations delved into review of a customized Political Parties Financial Reporting Template recently spearheaded by ORPP. Also in discussions was the Political Parties (Amendment) Bill, a review of PPLC's current financial status for the financial year, PPLC legal reform report, implementation of PPLC activities and legal reform proposals aimed at improving PPLC operations and larger electoral framework.

Registrar of Political Parties, Ann Nderitu, CBS, commended the spirit of openness and continued dialogue among the stakeholders. "Such engagements are crucial in promoting peace, building trust, and strengthening confidence in the electoral processes while embracing political tolerance, elements central to the growth of democracy," she noted.

Speaking on the Committee's legal reform agenda, Assistant Registrar for Regulation and Compliance, Ali Abdullahi, emphasized the instrumental role of PPLC in identifying legal gaps and enhancing inclusivity, transparency, and advocacy in the political landscape.

Historic moment as Registrar at go issues six political parties with provisional registration certificates

The Office, on 14th June, 2025 registered a milestone in the political party registration process with the issuance of provisional registration certificates to six (6) newly formed political parties. The event, held at ORPP headquarters in Nairobi, was presided over by Registrar of Political Parties, Ann Nderitu, CBS, and attended by founding members of the respective parties and ORPP officials.

The political parties awarded provisional registration certificates included: Imarisha Uchumi Party (IUP); People's Forum for Rebuilding Democracy (PFRD); Alliance for Democratic Association (ADA); The Inclusive Party (TIP TIP); United Patriotic Movement (UPM); National Transformation Party (NTP). In her remarks, Registrar, Ann Nderitu, CBS, congratulated the party founders for reaching this important stage and reminded them that provisional registration is a crucial yet preliminary phase in the full registration process. "You must have ORPP, approved recruitment systems that are compliant with data protection laws. Be thorough with your documentation and organizational structures as you embark on the journey toward full registration," she advised.

The Registrar also urged the party leaders to foster co-

Assistant Registrar, CPA Florence Birya, emphasized that registration is not just a formality, but a commitment to uphold the values of democratic governance. "Being registered today is your opportunity to contribute to progress in the political system in Kenya. Stay true to your founding ideologies and adhere to the Political advised.

Speaking on the legal requirements post-provisional registration, Locha Erukudi, Deputy Director, Registration department guided the parties. He stated "From the date of issuance, you have 270 days to meet the legal requirements for full registration. This includes establishing inclusive internal governance structures, conducting legitimate membership recruitment, and opening party offices as required by law," he noted.

The party officials were assured of ORPP's continued support towards registration process and eventual compliance.

ORPP sensitizes parties' PWD leadership, spearheads formation of a disability caucus

The Office, on 4th June 2025, in Nairobi, sensitized leaders of PWDs party leagues drawn from over 47 registered political parties. The engagement aimed to The Registrar of Political Parties Ann Nderitu, CBS, political parties assess the milestones achieved in advancing disability inclusion within political parties, identify existing gaps, and chart pathways for enhanced participation and representation of PWDs in Kenya's political landscape.

Speaking during the forum, Registrar Ann Nderitu, CBS, emphasized the indispensable role of inclusive political processes, stating, "The political and electoral processes cannot be complete without the inclusion of all demographics, including Persons with Disabilities. You must enhance your collective efforts to advocate for and protect the rights and spaces of PWDs within political parties and the broader society."

One of the major outcomes of the meeting was the formation of a PWDs Caucus, comprising representatives from political parties with the guidance and support of ORPP. The caucus will serve as a structured platform for advocacy, engagement, and coordination of initiatives aimed at promoting meaningful inclusion. A select committee was also constituted to steer the caucus's agenda, with a focus on enhanced funding mechanisms, awareness campaigns, capacity building and inter-party collaboration to support PWDs' active political participation.

Assistant Registrar, Ali Abdullahi, hailed the initiative as Caucus during the meeting a progressive step toward inclusive governance. He reaffirmed ORPP's commitment to supporting PWDs through policy formulation, legal reforms, and structured sensitization programmes. "Political parties must integrate inclusive strategies that go beyond tokenism to truly uphold the rights of PWDs," he noted.

During the interactive sessions, participants called for mechanisms to ensure PWD representation within party structures, stressing that lived experiences must shape policy and decisionmaking. Many underscored the need for leadership opportunities that allow PWDs to champion their own issues from within political frameworks.

Speaking during the session, Registrar of Political Parties, Ann Nderitu, CBS, emphasized the significance of aligning HR policies with emerging legal, policy, and workforce dynamics.

"The ORPP prides itself as an employer of choice through continuous development and review of such instruments. These frameworks are not only vital in ensuring a competent and motivated workforce, but also in enhancing career advancement in specialized areas," she noted.

He also led in addressing questions and clarifying matters raised by staff during the interactive session.

CPA Florence Birya, also an Assistant Registrar, encouraged staff to adopt a mindset that embraces change, emphasizing that agility and adaptability are essential to leveraging the opportunities presented by new systems.

Head of Human Resource Management, D. Mwendwa, who spearheaded the forum, underscored the role of personal accountability in career growth. "Each of us must take charge of our individual career development and align with the stipulations outlined in the HR instruments," she urged.

Senior Chief Finance Officer/Director of Finance who also chaired the ORPP Job Description and Evaluation Committee (JDAC) appreciated the growth of ORPP human capital structures including expanded job horizons. He called on staff to take advantage of well-defining career progression to advance their career as they apply their skills to the service o ORPP.

His counterpart, Director of Compliance, D.N. Kinuthia, urging staff to always make reference to the progressive instruments as they undertake their duties.

Staff present lauded the instruments as a premise to their professional development and efforts towards excellence in service delivery.

The grading structure was further subjected to Salaries and Remuneration Commission (SRC) who have since released the grading outcome out of the Job Descriptions submitted. The process will conclude by SRCs releasing ORPP salaries pegged on the new gradings.

Registrar mentors youth in politics and governance

As part of its ongoing commitment to fostering inclusive governance, the Office continues to champion the empowerment of youth in political and leadership spaces. This was evident during a high-level roundtable discussion held on 7th May, in Nairobi, where Registrar of Political Parties, Ann Nderitu, CBS, was among the lead speakers.

The event, hosted by Konrad-Adenauer-Stiftung (KAS), brought together young leaders drawn from universities and political parties, aiming to deepen their understanding and engagement in the political and policy-making processes. The focus was on practical avenues for youth involvement in political parties, leadership structures, and electoral systems.

Speaking during the session, Registrar Ann Nderitu lauded the initiative, emphasizing the importance of youth-driven reforms and active participation.

"I urge young people to utilize political party structures to advocate for reforms that enhance political engagement and democratic accountability," she said. She further noted that youth are not merely future leaders but key players in the present democratic landscape.

The Registrar also elaborated on ORPP's multi-faceted initiatives to promote youth inclusion, which included; Monitoring compliance by political parties in meeting youth representation thresholds as per legal and policy requirements; Ensuring political party structures are youth-responsive and provide opportunities for meaningful involvement; Continuous capacity building and

mentorship programs targeting youth leaders within parties; Development of manuals and policy guidelines tailored to support youth-friendly party policies; Encouraging political parties to allocate resources specifically for youth development within their broader programs. These efforts, she stated, are aimed at equipping young people with the tools and institutional support necessary to navigate and influence political spaces constructively.

Country Director of Konrad Adenauer Stiftung (KAS), Mathias Kamp, reinforced the importance of youth in strengthening democratic governance.

"Youth must be seen not just as participants but as shapers of political thought and champions of responsive leadership," he remarked.

The interactive forum featured in-depth training on topics such as: Political identity and ideology; Roles and functions of political parties; Strategies to enhance youth participation in politics; The mandate and functions of ORPP.

The ORPP officers from the Partnerships and Linkages, and Registration departments were also present, providing technical insights and engaging directly with participants.

Participants expressing enthusiasm and a renewed sense of purpose to advocate for youth-centered policies within their respective institutions and political parties.

The Office has partitioned its three regional offices of Machakos, Kisumu and Mombasa, a project that has run in May and has been successfully completely June, 2025 as per project timelines.

The works as per requirements of setting up government offices, were spearheaded by Technical Officers (Engineers) from the State department of Public Works, Ministry of Lands, Public Works, Housing and Urban Development. The officers provide technical assistance including the architectural designs and all

related works.

The works have been undertaken by procured contractors.

It is headed by Head, Administration, Jane Kamau with membership comprising Director Finance and Accounting Services, and departmental heads of Field Services Coordination, Corporate Communication, Accounting Services and ICT with ground support of respective Field Coordinators.

Speaking at the same event, Deputy Director of Registration, Mr. Locha Erukudi, elaborated on the provisions of Section 7 of the Political Parties Act. He underscored the importance of forming inclusive and representative party structures, particularly to gender equity and youth representation, while ensuring that internal dispute resolution mechanisms are embedded in their governance structures.

The certification of the two brings provisionally registered as at June to 16 parties while fully registered remained at 91 parties.
